Van's Aircraft, Inc. RV-12 S-LSA Limited Warranty

Limited Warranty

Van's Aircraft warrants the aircraft and all parts included therein to be free from defects in material and workmanship under normal use and service for a period of twelve (12) months or 500 hours (whichever occurs first) after the warranty start date, except as hereafter noted. Engines, engine parts and accessories, avionics, batteries and propellers are specifically excluded from this warranty. Spare parts sold by Van's Aircraft, excluding engines, engine parts and accessories, avionics, batteries and propellers are warranted for six (6) months after installation, except as hereafter noted.

Van's Aircraft's obligation under this warranty is limited to repairing or replacing, at its option, with exchange, overhauled, or new parts, items found defective by Van's Aircraft's examination which are returned at the owner's expense within the applicable twelve (12) months or 500 hours (whichever occurs first) or, for spare parts, the remaining portion of the applicable six (6) months warranty period.

A new warranty period is not established for replacement parts. Replacement parts are warranted only for the remainder of the applicable twelve (12) months or 500 hours (whichever occurs first) or, for spare parts, the remaining portion of the applicable limited warranty period.

The repair or replacement of the defective parts under this warranty will be made without charge to the owner for parts and labor for removal, installation and/or actual repair, except that the owner shall pay all import duties and sales and use taxes on replacements and repairs. **Warranty claims must be referred to Van's Aircraft, Inc for approval prior to any remedial work. Repair or replacement of parts must be at a facility approved by Van's Aircraft, Inc.**

This limited warranty does not apply to parts subjected to misuse, negligence, improper installation, accident, alteration; repairs not authorized by Van's Aircraft; normal maintenance services (cleaning, control rigging, brake and other mechanical adjustments, maintenance inspections, etc.); replacement of service items (light bulbs, brake linings, filters, hoses, tires, engine vibration dampeners, etc.) due to corrosion, wear and exposure.

WITH THE EXCEPTION OF THE WARRANTY OF TITLE, TO THE EXTENT ALLOWED BY APPLICABLE LAW, THE WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER WARRANTIES, EXPRESSED OR IMPLIED IN FACT OR BY LAW, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Van's Aircraft RV-12 Limited Paint Warranty

With proper care, the finish on your new RV-12 should remain in good condition for many years.

For the first 90 days, the paint on your aircraft may still be curing and should be cleaned with mild soap and water only and hand dried with a clean, non-abrasive cloth. Do not apply wax or polish. After 90 days, wax and/or polish can be applied by hand. Do not use a power buffer as it may damage the paint finish.

As with the other parts of the aircraft, routine maintenance must be performed on the exterior finish to ensure maximum service life. Maintenance should include but is not limited to reasonable protection from harsh weather and/or environmental conditions, routine cleaning, waxing and polishing as well as timely touch up of chips or wear in the paint when they occur in any part of the finish.

Warranty: Paint and Graphics are warranted only for defects in materials and workmanship for a period of one (1) year or 500 hours (whichever occurs first) from the warranty start date. Deterioration of the paint and graphics due to normal wear, exposure, or improper maintenance and care is not covered by the warranty. Finish deterioration on immediate leading edges of flight surfaces is not covered by the warranty.

Unless specifically approved by Van's Aircraft, warranty repair of paint will be confined to the limited surface area of the defect. Complete strip and repaint of an entire aircraft will ONLY be authorized if it is determined by Van's Aircraft that there is materials and/or workmanship defects on several major surfaces.

Powerplant Warranty: Rotax 912ULS

The powerplant warranty for your new aircraft is limited to the Standard Manufacturer's Warranty. See Rotax Service Letter SL-912-012 R2 for warranty details on the engine and its components.
